Message from *Katie*



As we enter into our new fiscal year I would like to let you know how your local contributions are changing lives through the work of the American Red Cross.

This year alone we assisted with 19 disaster operations and assisted 13 families financially. Several of these homes were totally destroyed. It has been an expensive but important year.

We had 26 blood drives and collected 1,096 units of blood, falling short of our goal by 11%. The need for blood is constant. We really want to encourage everyone to come and donate. If you have questions don't hesitate to call (740) 335-3101.

We certified 417 individuals in first aid and CPR. In addition, 4,055 residents learned about disaster preparedness through canvassing, puppet shows and presentations.

Now accepting applications for one year assignments

The position gives one the opportunity to: Teach and develop Community Disaster Education, Teach CPR and First Aid, Work with Disaster Response, recruit and train volunteers, work with blood donor recruitment.

Requirements: Be at least 18 years old, be a US citizen or legal resident, have a High School diploma, have a valid Driver's License.

Benefits: One will receive a stipend of \$11,400 for full time service, obtain an Education Award of \$4,725, receive health care coverage through an AmeriCorps provider, may qualify

for child care assistance, deferment of student loans.

Steps to Apply:
